Please plan to be a part of the **60th Annual Frankfort Jaycees Christmas Parade!** This holiday tradition, started by the original members of the Frankfort Jaycees in 1949, is the longest running annual community event in Franklin County. The Frankfort Jaycees are looking forward to joining the entire community in ringing in the 2008 holiday season.

This year's Christmas parade will be held on Saturday, December 6th. Step-off for the parade will again be at 5:30 p.m.

The staging area will be on Clinton Street – from Ann Street back into the parking area of the Old State Office building at the intersections of Clinton, High and Mero Streets. The route will follow Ann Street to Main to Capital Avenue and end at the Capitol. Upon ending, we ask that all parade participants join Governor and Mrs. Beshear for the lighting of the State Christmas Tree and a candlelight tour of the Capitol and Governor's Mansion.

Through out 2008, the Frankfort Jaycees have been participating in events and fundraising for the Make-A-Wish® Foundation. So in recognition of the wishes that we helped become reality, this year's parade theme is ***Christmas Wishes***. One of the children whose wish we made come true has been invited to serve as co-grand marshal along with Governor and Mrs. Beshear. We know you will create wonderful, imaginative floats that are keeping with the *Christmas Wishes* theme. Awards will be presented immediately following the parade for 1st, 2nd and 3rd places and for the best themed float.

Parade participants must carefully read, complete and sign an Official Entry Form and Parade Rules (enclosed) and submit it along with the appropriate entry fee as detailed below to: Frankfort Jaycees Christmas Parade, P.O. Box 1025, Frankfort, KY, 40602-1025. All entries must be **postmarked by Friday, November 21, 2008**. After this date, please include an additional \$25 late fee. The entry fees are as follows:

- * Churches and Non-Profit Organizations..... \$25
- * Businesses and For-Profit Organizations..... \$50
- * Entries Added on Parade Night.....\$100 (money in-hand only)
